2020 Annual General Meeting

Consumer Affairs Victoria (CAV) is the Victorian government agency responsible for registering and regulating incorporated associations in Victoria. As an Incorporated Association in Victoria we must comply with the Associations Incorporation Reform Act 2012 (Vic) and conduct an Annual General Meeting (AGM) no later than 5 months after the end of our financial year.

Given that many QCC members have been living in isolation from their own families and friends since late March, they may have some catch-ups planned over the coming weeks as Covid-19 restrictions are eased, allowing for more movement and larger assemblies for social gatherings. With this in mind, the IBM Quarter Century Club of Victoria has opted to hold its 2020 AGM as a virtual meeting using the Zoom App to enable QCC members to join via telephone or video from locations all over Australia.

To minimize conflict with family or other social activities the AGM will be held from 3:00pm to 4:00pm on Sunday, 26th July. A Formal Notice of the AGM and its agenda will be distributed in late June along with an invitation to participate in the Zoom Meeting.

*Please note that any QCC qualifier and their partner may participate in the AGM but voting on any motions, or election of candidates nominating for the Committee, is restricted to those who are financial members of the **IBM Quarter Century Club of Victoria Inc** at commencement of the AGM. A financial member of the association may submit a proxy form nominating another financial member to vote on his/her behalf should they not be able to participate in the AGM.*

Call for Nominations - Office Bearer and/or Committee

Under our Constitution, all Office Bearer and Committee Member positions must be declared vacant at each Annual General Meeting and Nominations called for each position. If more than one nomination is received for any position an election must be conducted and votes taken from those eligible to vote at that AGM including any who have submitted proxy nominations.

Judy Horman has submitted written notice of her intent to stand down from the position of Secretary at the 2020 Annual General meeting. As the Secretary position must be filled within 14 days of it becoming vacant, all QCC members in Victoria are asked to consider nominating for this position, or to encourage nomination of other members whom they consider ideal candidates.

Nominations for the position of Secretary or other Office Bearer or Committee Member positions are sought in advance of the 2020 Annual General Meeting to give all members the opportunity to nominate or vote for the candidates of their choice.

It is not a requirement for nominees to be present at the AGM to be considered for election. Please refer to Part 5 of our Constitution for further details on the roles and responsibilities of the Committee. 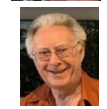
